e-TENDER NOTICE

ANIMAL HUSBANDRY DEPARTMENT, KERALA

Purchase of 139 Numbers of Tablets for the use of Mobile Veterinary Units and Mobile Surgery Units of Animal Husbandry department for the year 2025-26

Sealed and competitive e-tenders are invited from the manufacturers/authorized dealers or suppliers of **Tablets** having service centres within Kerala State, under "Two cover system" for the Purchase of 139 Numbers of Tablet or the use of Mobile Veterinary Units and Mobile Surgery Units of Animal Husbandry Department for the year 2025-26.

In accordance with respective specifications as shown in the tender documents, the tender is to be submitted as e-tenders through etenders.kerala.gov.in. Since this is an online process only those bidders who have enrolled in the above portal with their own Digital Certificate (DSC) can participate in the tender. E-tender document and other details will be obtained from the above portal. Bidders are also requested to send **hard copies of documents, such as Preliminary Agreement, Product**

Specification, Brochure, Test Reports etc., before the date and time of opening bid to Office of the Directorate of Animal Husbandry Thiruvananthapuram.

The Tender process shall consists of the following stages:

- i. Downloading of tender document: Tender document will be available for free download on www.etenders.kerala.gov.in. However, tender document fees shall be payable at the time of bid submission as stipulated in this tender document.
- ii. Pre-bid meeting: Nil
- iii. Publishing of Corrigendum: All corrigenda shall be published on www.etenders.kerala.gov.in and shall not be available elsewhere.
- iv. Bid submission: Bidders have to submit their bids along with supporting documents to support their eligibility, as required in this tender document on www.etenders.kerala.gov.in. No manual submission of bid is allowed and manual bids shall not be accepted under any circumstances.
- v. In case bidder encounters any technical issues pertaining to e-Procurement system while acting on the tender, computer screen shot of the error message with date & time stamp on the web-browser along with the query shall be e-mailed by the bidder to the help desk (helpetender@gmail.com/ etendershelp@kerala.gov.in), for resolution of the problem. At the same time, matter must be intimated to the concerned Tender Inviting Authority via email.
- vi. The time taken to ascertain, evaluate and suggest a solution for the problem reported by bidder may vary from case to case. Hence bidders are advised to submit the bid at least 2 working days before the due date and time of bid submission to avoid any last minute issues that may come up.
- vii. Opening of Technical Bid and Bidder short-listing:- The technical bids will be opened, evaluated and shortlisted as per the eligibility and technical

qualifications. All documents in support of technical qualifications shall be submitted (online). Failure to submit the documents online will attract disqualification. Bids shortlisted by this process will be taken up for opening the financial bid.

viii. Opening of Financial Bids: Bids (Technical Bid) of the qualified bidder's shall only be considered for opening and evaluation of the financial bid on the date and time mentioned in critical date's section.

C. Documents Comprising Bid:

First Cover (Cover A - Technical) should have the following enclosures:-

1. Detailed Specification of item, without rate and with the list of institutions where supply has to be effected. The make of the item quoted should be mentioned.
2. Original or attested copy of manufacturing license in case of manufacturer. Original or self-attested copy of trade license in case of suppliers.
3. A declaration of the supplier/ manufacturer making the supply of the materials to the effect that the supply of the materials will be done within 30 days from the date of receipt of the supply order.
4. Catalogues with photographs with detailed specifications of the quoted item should be produced.
5. A copy of the ISO/BIS certificate if any, shall be produced.
6. GST certificate.
7. Preliminary agreement in Kerala stamp paper worth Rs. 200/- . (Copy of Agreement attached).

8. Name, address, RTGS/IFSC code of the bank with which, the firm holds financial transactions.
9. Payment details. (Proof for payment of GST amount and Tender fee)
10. 3 years Experience certificate (market standing).
11. Proof for showing the bidder firm having authorised service centres within Kerala State.

Second Cover (Cover B-) should have the following enclosures:

1. Rate should be quoted as basic price, rate of tax, and total amount.
2. Details of EMD paid (Rs.36,140/- 1 % of the estimated amount).
3. EMD exemption certificate (if any) should be submitted online.
4. BOQ duly filled uploaded in the etender Portal
6. Technical data sheet duly filled up and signed
7. If any more information to be furnished

Original tender form duly signed by authorized signatory. Both Technical bid and Financial bid documents must be effectively uploaded. Technical bid and Financial bid will be opened as per the schedule given below. Financial bid of those tenderer who satisfy the conditions in the Technical bid will only be opened. The tender details for the supply of 139 Tablets for the use of Mobile Veterinary Units and Mobile Surgery Units for the year 2025-26 can also be had from the Animal Husbandry Department website www.ahd.kerala.gov.in. Late tenders will not be considered under any circumstances.




1. All offers should be in the original packaging of the Manufacturer/Supplier.

3. The successful bidder will have to execute an agreement in Kerala Stamp Paper worth Rs 200/- in prescribed form and to furnish the required security deposit @ 5% of the total quoted amount within 15 days of the receipt of supply order.
4. The Security Deposit (5% of order value) should be furnished as Account Payee Demand Draft/Bank Guarantee from a nationalised Bank (valid up to the risk liability period) or Treasury Deposit and will be released only after satisfactory completion of the contract.
5. The rates should be for delivery on F.O.R. (Freight on Road) basis in

any part of the State.

6. The payment shall be released only after satisfying the quantity, Quality, specification of the items supplies and success of the trial run and installation of the equipment.
7. Bidder has to pay the GST portion of the tender directly to GST
8. The Bidder should submit authorised dealership/distribution ship certificate from manufacturer/ letter from authorised dealer confirming supply of authentic product with service and guarantee.
