ORDER

The Kerala Public Service Commission, Thiruvananthapuram, vide paper read 1, have advised 114 candidates for appointment to the post of Veterinary Surgeon Gr.II in the scale of pay of ₹ 55,200-1,15,300/- in the Animal Husbandry Department.

The following candidates are appointed temporarily as Veterinary Surgeon Gr.II in the scale of pay of ₹ 55,200-1,15,300/- in the stations noted against their names. The advice of the candidates is subjected to Rule 3(C) of the General Rules of KS&SSR of 1958. The appointment is purely provisional under Rule 9(a) (1) of the General Rules as provided for in Rule 10(b) of those rules. This provisional appointment shall be regularized only after the receipt of verification report from the Police Department and verification report of KPSC authorities and will also be subject to provisions of G.O.(P)No.41/2010/P&ARD dated 14/12/2010 and subsequent Government orders.

The candidates should report before the District Animal Husbandry Officers/Controlling Officers concerned with all documents with reference to the proof of date of birth, community, qualifications, health and character certificate from Gazetted officers in original. Request if any made in future for the correction of date of birth will be entertained only according to the provisions in G.O.(P)No.45/91/P&ARD dated 30/12/1991.

The Controlling officers should admit the candidates after satisfying themselves about the identity of the candidates with reference to their signature and identification certificates & other credentials. The candidates shall fill the proforma for verification of the character and antecedents and personal memorandum and the same is to be forwarded to this office immediately by the Controlling officer duly attesting the photograph and with the certificate (below the declaration of the candidate). SPARK FORM No.1 also should be duly filled and submitted to the Controlling Officer. The candidate should also submit medical fitness certificate issued by a Medical Officer not below the rank of Assistant Surgeon duly affixing the candidate's recent passport size photograph and thumb impression on the medical certificate duly attested by the Medical Officer, as prescribed in G.O.(P)No.20/2011/ P&ARD dated 30.06.2011.

• The certificate of transfer of charge in respect of joining duty is to be forwarded to the Accountant General (A&E), Ernakulam and the Controlling officers concerned without

fail.

• The candidate shall join duty within 15 days from the date of receipt of this order. Otherwise the advice will be cancelled by the Public Service Commission, unless extension of joining time is granted by the competent authority.

• The Officers appointed as per this order will be on probation for a period of two years duty within a continuous period of three years and they should pass the Account Test for Executive Officers of Kerala and Animal Husbandry Department Manual Test, during the period of probation.

The Director of Animal Husbandry, Kerala invited off-line transfer applications from the existing Veterinary Surgeons of the Department in compliance with the judgment of Kerala Administrative Tribunal dated 12-03-2026 in the cases, OA1564/2025 & MA-1936/2025 vide proceedings No. AHD/2133/2026-D2 dated: 15-03-2026. As the stations allotted as per this order are included in the 'Likely Vacancy List' and fall within the scope of the offline mode of the aforementioned general transfer, the postings to these stations as per this order shall be subject to change in accordance with the final transfer list as per the said General Transfer Order.
