NOTIFICATION

S. R. O. No. 591/2005.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Special Rules for Kerala General Service issued under Notification G. O. (P) No. 464/66/Public (Rules) Department dated 28th November, 1966 and published in Part I of the Kerala Gazette No. 49 dated the 13th December, 1966, namely:—

33/2359/2005/DTP. (redgiH) 1267

1. *Short title and commencement.*—(1) These rules may be called the Special Rules for Kerala General Service (Amendment) Rules, 2005.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Special Rules for the Kerala General Service,—

(1) in Rule 1,—

(a) under category 1A, after the item, "Accounts Officer, Vigilance Department", the following item shall be inserted, namely:—

"Accounts Officer, Office of the Director of Animal Husbandry".

(b) under category 2A, for the words, "Accounts Officer/Chief Accountant in the Animal Husbandry Department", the following words shall be substituted, namely:—

"Senior Superintendent (Accounts)/Chief Accountant in the Animal Husbandry Department".

(2) in Rule 2,—

(a) under category 1A, after the words "Accounts Officer/ Administrative Assistant, Vigilance Department" in column (1) and the entries against it in column (2), the following words shall respectively be inserted in columns (1) and (2) namely:—

1. By appointment from the category of
Administrative Assistant in the Depart-
ment of Animal Husbandry having
Account Test (Higher)

or

2. By promotion from the category of

Account Test (Higher)"

(b) under category 2A, for the words, "Accounts Officer/Chief Accountant in the Animal Husbandry Department" in column (1), the following words shall be substituted, namely:—

"Senior Superintendent (Accounts)/Chief Accountant in the Animal Husbandry Department".

in Rule 5, in the table,—

(a) under category 1A, after the words, "Accounts Officer, Vigilance Department" in column (1) and the entries against it in column (2) and (3), the following words shall, respectively be inserted in column (1), (2) and (3), namely:—
