ORDER

The Kerala Public Service Commission, Thiruvananthapuram, vide letter read above has advised 15 candidates for appointment to the post of Veterinary Surgeon Gr.II in the scale of pay of Rs.39,500-83,000 in Animal Husbandry Department.

The following candidates are appointed temporarily as Veterinary Surgeon Gr.II in the scale of pay of Rs.39,500-83000 at the station noted against their names. The advice of the candidates is subject to Rule 3(C) of the General Rules of KS&SSR of 1958. The appointment is purely provisional under Rule 9(a) (1) of General Rules as provided for in Rule 10(b) of those rules.**This provisional appointment will be regularized only after the receipt of the verification report from Police Department and verification report by KPSC authorities and also subject to provisions of G.O. (P)No.41/2010/P&ARD dated 14/12/2010 and subsequent Government orders.**

The candidate should report before the District Animal Husbandry Officer (Controlling Officer) concerned with all documents in proof of date of birth, community, qualifications, health and character certificate from Gazetted officers in original.**The candidate should also produce the original one time verification certificate of Kerala Public Service Commission at the time of reporting for duty. The candidate who fails to produce original one time verification certificate shall not be admitted to duty under any circumstances.** Request if any made in future for the correction of date of birth will be entertained only according to the provision in G.O.(P)No.45/91/P&ARD dated 30/12/1991.

The controlling officer should admit the candidates after satisfying himself about the identity of the candidates with reference to their signature and identification certificates.

The candidates shall fill the proforma for verification of the character and antecedents and personal memorandum and the same is to be forwarded to this office immediately **by the controlling officer duly attesting the photograph and with the certificate (below the declaration of the candidate)**. SPARK FORM NO.1 also should be duly filled and submit to the controlling officer. The candidate should also submit Medical Fitness certificate issued by a Medical Officer not below the rank of Assistant Surgeon duly affixed his/her recent passport size photograph and thumb impression on medical certificate duly attested by the Medical Officer, as prescribed in G.O. (P)No.20/2011/P&ARD dated 30.06.2011.

- The certificate of transfer of charge in respect of joining duty is to be forwarded to the Accountant General (A&E) Ernakulam and other controlling officers without fail.
- The candidate shall join duty within 15 days from the date of receipt of this order, otherwise the advice will be canceled by the Public Service Commission, unless extension of joining time granted by the competent authority.
- The Officers appointed as per this order will be on probation for a period of two years duty within a continuous period of three years and they should pass the Account Test for Executive Officers of Kerala and Animal Husbandry Department Manual Test, during the period of probation.
